Item 8.01 Other Events.

Effective February 3, 2009, TapImmune, Inc.(the "Company") increased its authorized share capital of common shares from 80,000,000 common shares with a par value of \$0.001 per share to 500,000,000 common shares with a par value of \$0.001 per share (the Company's number of authorized shares of preferred stock, par value \$0.001 per share, remains unchanged at 5,000,000 shares).
